

**Terms & Conditions of “Pay your UOB Credit Card bill now and be rewarded!” (“Promotion”)**

This Promotion is carried out by United Overseas Bank (“UOB”) and AXS Pte Ltd (“AXS”) and is subjected to these terms and conditions (“Terms”).

**ELIGIBILITY**

- 1. The Promotion is open to all UOB cardmembers (“Eligible Customers”). Employees of AXS and their spouses (if applicable) are not eligible to participate in the Promotion. Employees of UOB and its agencies and auditors who are directly involved in the Promotion are not eligible to participate in the Promotion.
- 2. AXS may from time to time in its absolute discretion decide on the eligibility for participation in the Promotion.

**PARTICIPATING CHANNELS:**

- 3. Only eligible payment performed on the following AXS channels will qualify for the Promotion (“Participating Channels”):
  - AXS Station
  - AXS e-Station
  - AXS m-Station

**PROMOTION PERIOD:**

- 4. The qualifying period for the Promotion shall commence from 9 April 2024, 10:00 to 31 July 2024, 23:59 both dates inclusive (“Promotion Period”).

**QUALIFYING TRANSACTION AND CHANCE ALLOCATION:**

- 5. Eligible Customer must successfully perform the following on the Participating Channels during the Promotion Period to be eligible for the Promotion (“Qualifying Transaction”):

- 6. Chances are cumulative throughout each Transaction Period.
- 7. There is no limit to the number of chances the Customer may be eligible for during the Transaction Period.

8. Chance(s) is non-transferable and cannot be combined with chance(s) accumulated by any other Customers.

### **THE PRIZES**

9. There shall be eight (8) winners for the Promotion.

15. AXS reserves the right to forfeit any Prizes for any winners who do not provide the required information upon the request of AXS.
16. Any unclaimed Prize(s) within the given collection period will be forfeited without any liability on the part of AXS and UOB. AXS may donate any forfeited Prize(s) to a charitable organisation of AXS's choice.

**CONDUCT OF DRAW:**

19. The draw will be conducted on 8 August 2024 ("Draw Date"), 10.30am at 53 Mohamed Sultan Road, #01-K1 Sultan Link, Singapore 238993 (or any other date, time and/or venue determined by AXS).

20. On the Draw Date, eight (8) winners and eight (8) reserve winners will be selected at random by means of a computerized or electronic system. The reserve winners are drawn to replace any winner subsequently disqualified if any. AXS's decision as to the winner and reserve winners of the Promotion shall be final and conclusive.

21. All winners will be contacted through phone. AXS will attempt to make **three (3)** phone calls to each winner, from phone number (+65) 6560 2727, to obtain their full particulars for verification purposes. In the event that AXS is unable to contact a winner after **three (3)** phone calls, AXS will choose an eventual winner from the reserve winner list of the respective Qualifying Period.

22. 24. AXS's decision as to the winners and reserve winners of the Promotion shall be final and conclusive.

25. All the winners will be notified via phone and email.

**PRIZE COLLECTION:**

26. Upon confirmation of the verification, all winners will receive the winner letter via email. Winners are to arrange with the retailer for the redemption of the Prize.

27. Winners shall collect their Prize within the collection period and at the appointed venue specified by AXS and/or the retailer in the winner letter and shall comply with any

instructions specified. In the event a winner fails to collect the Prize within the stipulated collection period and/or fails to comply with any other instructions or conditions specified in the winner letter, the Prize may be forfeited at AXS's absolute discretion.

28. AXS may donate any forfeited Prize(s) to a charitable organisation of AXS's choice.
29. AXS reserves the right to disqualify an otherwise eligible Customer from winning a Draw Prize and/or substitute another Customer as the winner in the event that AXS in its absolute discretion believes that the particular Customer may have contravened, will contravene or has contravened any of these Terms and/or may bring AXS into disrepute. 38. AXS and/or UOB reserves the right at any time to amend or delete these Terms and/or any of the instructions or explanations at its sole discretion without prior notice. Any such changes shall be binding and will take effect immediately upon such amendment, change or deletion. Participation in this Promotion shall constitute acceptance of these Terms and any amendment(s) thereof.
39. In the event of any inconsistency between these terms and conditions and any brochures, marketing or promotional materials relating to the Promotion, these terms and conditions shall prevail.
40. These terms and conditions are governed by Singapore law and the Eligible Customers agree to submit to the exclusive jurisdiction of the Singapore Courts.

A person who is not a party to these terms and conditions shall have no right under the Contracts (Rights of Third Parties) Act (2001) to enforce any of these terms and conditions and notwithstanding any terms herein, the consent of any third party is not required for any variation (including any release or compromise of any liability) or termination of the Campaign.
