- 12. The eVoucher will automatically be used to offset parking charges upon exit.
- 13. The eVoucher must be redeemed within ninety (90) days from the date of issue as indicated on the eVoucher.
- 14. The eVoucher is valid for use at any participating car parks of AXS Drive.
- 15. No minimum parking charge is required to utilise the eVoucher.
- 16. If the eVoucher value is not fully utilized, the balance value will not be refunded.
- 17. If parking charge exceed the eVoucher value, the balance charge will be deducted from the registered Mastercard credit/debit card.
- 18. The eVoucher is strictly non-refundable, non-exchangeable, and non-transferable.
