

Terms and Conditions for “Win a Shark Wandvac Handheld Vacuum with AXS” (“Promotion”)

The Promotion is organised by AXS Pte Ltd (“AXS”).

ELIGIBILITY:

1. This Promotion is open to all existing AXS customers, who make Qualifying Transaction (as defined in Clause 6) on Participating Channels (as defined in Clause 4) (“Eligible Customer”).
2. Employees of AXS are not eligible to participate in the Promotion.
3. AXS may from time to time in its absolute discretion decide on the eligibility for participation in the Promotion.

PARTICIPATING CHANNELS:

4. Only eligible payments performed on the following AXS channels will qualify for the Promotion (“Participating Channels”).

PROMOTION PERIOD:

5. The Promotion shall commence from 9 October 2024, 09.00 AM to 9 April 2025, 11.59 PM both dates inclusive (“Promotion Period”).

QUALIFYING TRANSACTION AND CHANCE ALLOCATION:

6. Eligible Customers must successfully perform a transaction with a minimum payment amount of S\$10 to any of the following LTA services through the Participating Channels during the Promotion Period to be eligible for the Promotion (“Qualifying Transaction”).
 - (i) Road Tax Renewal
 - (ii) e-Day Licence Purchase
 - (iii) Vocational Licence Renewal
7. Chances allocation for Qualifying Transaction are as follows:
