

Notification of Changes to Terms and Conditions

Do note that with effect from 30 Sep 2025, clause 4,6,7,11 and 14 will be updated to reflect the following:

PROMOTION PERIOD & QUALIFYING PERIODS

4. The Promotion shall commence from 1 April 2025, 12:00 AM to **31 December** 2025, 11:59 PM ("Promotion Period").

The Promotion is organised by AXS Pte Ltd ("AXS"). All individuals participating in Promotion is subject to these terms and conditions ("Terms").

ELIGIBILITY:

1. This Promotion is open to the following individuals ("Eligible Customer"):
 - 1.1 Eighteen (18) years old and above,
 - 1.2 Singapore Citizens, Singapore Permanent Residents or foreigners residing in Singapore
2. The following people are not eligible to participate in and are disqualified from the Promotion:
 - 2.1 Any individual below eighteen (18) years old;

3. AXS may from time to time in its absolute discretion decide on the eligibility for participation of the Promotion.

PROMOTION PERIOD & QUALIFYING PERIODS

ELIGIBLE CHANNEL:

5. The Promotion is only available on AXS Drive mobile application ("AXS Drive").

MECHANICS:

6. Automatic Enrolment:

6.1 Eligible Customers are automatically enrolled in this campaign when they use AXS Drive to make payment for car park charges, ERP charges, or EV charging sessions during the Promotion Period. No separate registration is required.

7. Clarification on Spend Calculation:

Any promo codes, referral discounts, or complimentary voucher codes applied to car park, ERP, or EV charging transactions will not be included towards the \$30 accumulated spend.

Only the finalised payment amount (the actual amount paid by the Eligible Customer after discounts) will be counted towards this Promotion.

8. The Ya Kun voucher will automatically be issued in the "Rewards" section of the AXS Drive app upon reaching the \$30 threshold.
9. The spending tracker will reset on the 1st day of every month at 00:00, allowing users to start accumulating towards the next month's reward.
10. Any unused spending on the previous month does not roll over to the next month.

 - 13.7 Present the drink voucher within the Ya Kun Cherish app at participating Ya Kun stores to redeem the free drink

QUALIFYING TRANSACTIONS:

14. A Qualifying Transaction is defined as any payment made using AXS Drive for car park fees, ERP charges, or EV charging sessions.
 - 14.1 Regular car park fees, Regular EV Charging fees or ERP feesQualifying Transactions do not include any bills payment for motoring-related tax or fines.

15. Each Eligible Customer who meets the requirements will receive a promo code for a cup of Coffee or Tea (of their choice) from any Ya Kun Outlets (worth S\$2.20).
